# **Position**

The Board will support the work of The Gray Matter Experience and provide mission-based leadership and strategic governance. While day-to-day operations are led by Gray Matter's chief executive officer (CEO), the Board-CEO relationship is a partnership, and the appropriate involvement of the Board is both critical and expected. Specific Board Member responsibilities include:

## Leadership, governance, and oversight

- Work with the CEO to develop TGME's strategic plan
- Review outcomes and metrics created by TGME for evaluating its impact, and regularly measure its performance and effectiveness using those metrics
- Review agenda and supporting materials prior to board and committee meetings
- Approve TGME's annual budget, audit reports, and material business decisions; be informed of, and meet all, legal and fiduciary responsibilities
- Contribute to the annual performance evaluation of the CEO
- Assist the CEO and board chair in identifying and recruiting other Board Members
- Partner with the CEO and other board members to ensure that board resolutions are carried out
- Serve on committees or task forces and take on special assignments
- Represent TGME to stakeholders; acting as an ambassador for the organization
- Ensure TGME's commitment to a diverse board and staff that reflects the communities TGME serves

#### **Fundraising**

TGME Board Members will consider TGME a philanthropic priority and make annual gifts that reflect that priority. So that TGME can credibly solicit contributions from foundations, organizations, and individuals, TGME expects to have 100 percent of Board Members make an annual contribution of \$5,000 (either personally or through individual fundraising efforts).

## **Board Terms/Participation**

TGME's Board Members will serve a one-year term to be eligible for re-appointment for up to two additional terms. Board meetings will be held quarterly and committee meetings will be held in coordination with full board meetings. Board members can expect to spend between 10-15 hours per month between board meetings, projects and responsibilities.

# **Qualifications**

This is an extraordinary opportunity for an individual who is passionate about TGME's mission and who has a track record of board leadership. Selected Board Members will have experience in business, youth education and development, philanthropy, or the nonprofit sector.
